# **Characteristic Curves**





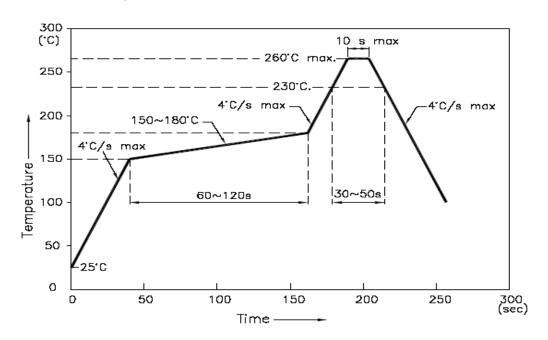


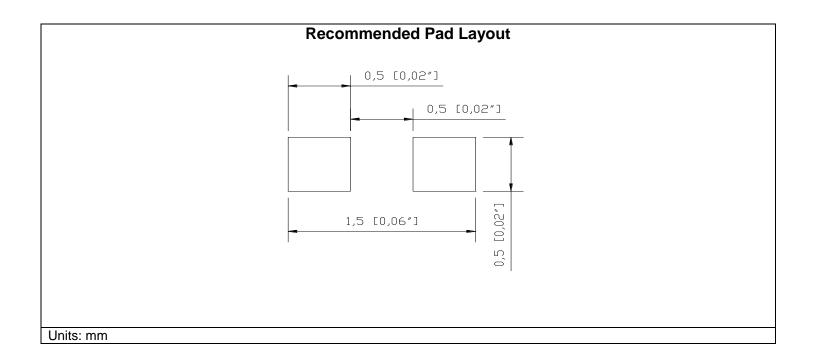

-The recommended reflow soldering profile is as follows (temperatures indicated are as measured on the surface of the LED resin):



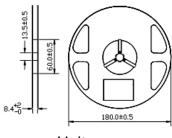

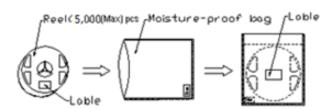

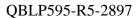
## **Arrangement of Tape:**
