

Description

The OPTIREG™ linear TLE4294GV50 is a monolithic integrated low drop out voltage regulator in a very small SMD package PG-SCT595-5. It is designed to supply e.g. microcontroller systems under severe conditions. Therefore the device is equipped with additional protection functions against overload, short circuit and reverse polarity. In case of an overtemperature condition the regulator is automatically turned off by the integrated thermal protection circuit.

Input voltages up to 40 V are regulated to $V_{\rm Q,nom}$ = 5.0 V. The output is able to drive a load of more than 30 mA, while it regulates the output voltage within a 4% accuracy.




Figure 1 Block diagram




Figure 2 Pin configuration (top view)

		For compensating line influences, a capacitor to GND close to the IC terminals is recommended.
4	Q	Output voltage Block to GND with a capacitor close to the IC terminals, respecting the values given for its capacitance CQ and ESR in the Table 3 "Functional range" on Page 6 (Tantalum capacitor recommended as output capacitor).
5	GND	Ground Connect to heatsink area; Connected to pin 2.




Figure 3 **Application diagram**




Figure 4 PG-SCT595-5¹⁾
